EVERY STUDENT SUCCEEDS ACT (ESSA)

- Federal legislation passed to allow for the use of methods and instructional strategies to strengthen the academic program in the school, increase the amount and quality of learning, and help provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.



Title I is a federally funded academic assistance program for schools.



The goal of Title I is to ensure a high-quality well-rounded education for every child.

WHAT IS TITLE I?

FOR SCHOOLS, ESSA:

Ensures schools measure student progress using approved tests.

Ensures schools issue reports charting school performance.

Provides teacher training and professional development to improve instruction.

Families will receive;

- Progress reports (twice a month)
- MAP Growth Assessment Report (3 times during the year)
- STAR & AR Program Progress Reports

FOR STUDENTS, ESSA:

Sets high expectations for academic achievement.

Requires yearly testing for Grades 3-8 and High School.

Provides teachers who are licensed by the state of Nevada and use proven teaching methods.

Grades K-2

- MAP: Reading & Math

Grades 3-5

- MAP: Reading, Math & Science

Grades 3-5

- SBAC

PARENTS' RIGHTS AND RESPONSIBILITIES

- The right to receive periodic progress reports on the child and the school.
- The right to request information about the qualifications of their child's teacher.
- The right to help decide if the school's Title I program is meeting the needs of their child.
- The right to offer suggestions for academic improvement and increased parental involvement.

PARENTS' RIGHTS AND RESPONSIBILITIES

continued

- The responsibility to share information with the teacher about their child's interests and abilities.
- The responsibility to attend parent conferences and to communicate regularly with the school concerning their child's academic progress.
- The responsibility to ensure their child attends school regularly, completes all homework and classroom assignments, and adheres to the District's Educational Accord, Honor Code, and school behavior policies.

WHAT DOES TITLE I PROVIDE AT MY CHILD'S SCHOOL?

■ Funds are used for:

- (2) CSR Teachers (primary & intermediate)
- STAR Reading & Accelerated Reader (software programs)
- Scholastic News (Literacy, Social Studies & Science supporting programs)
- Instructional Supplies (paper, toner, easel pads, notebooks, etc.)
